

ORDINANCE 07-02

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, AND COMMONWEALTH OF PENNSYLVANIA, DESIGNATING THE RATES FOR METERED WATER SOLD BY THE BOROUGH TO ITS CUSTOMERS, INCLUDING THE TOWNSHIP OF EAST DEER; ESTABLISHING A TEN PERCENT (10%) PENALTY FOR LATE PAYMENT AND REPEALING ORDINANCE 04-10 IN ITS ENTIRETY.

WHEREAS, labor costs, electricity costs and raw chemical costs to manufacture potable water have increased on a regular basis; and

WHEREAS, Council of the Borough of Tarentum has not changed rates sufficiently to compensate for increased costs of water production; and

WHEREAS, Council of the Borough of Tarentum desires to designate and amend its charges for metered water sold to Borough residents and to the Township of East Deer; now

THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Borough of Tarentum, and it is hereby ordained and enacted by authority of same that water rates are amended and shall be as follows:

SECTION I.

The rates for metered water shall be changed to read as follows effective January 1, 2007:

FOR ALL USAGE IN EXCESS OF 2,000 GALLONS PER MONTH THE CHARGE SHALL BE \$5.30 PER 1,000 GALLONS USED.

SECTION II.

A. JANUARY 1, 2007 BULK RATE FOR THE TOWNSHIP OF EAST DEER:

USAGE PER QUARTER	CHARGE PER 1,000 GALLONS	NEW RATE FOR USAGE
First 200,000 gallons	\$3.67	\$734.00
Next 200,000 gallons	\$3.42	\$684.00
Next 200,000 gallons	\$3.18	\$636.00

Next 200,000 gallons	\$2.78	\$556.00

B. THE ABOVE SPECIFIED TOTAL CHARGE FOR 1,000,000 GALLONS PER QUARTER IS \$3,204.00.

C. FOR ALL USAGE IN EXCESS OF 1,000,000 GALLONS PER QUARTER, THE CHARGE SHALL BE \$2.62 PER THOUSAND GALLONS USED.

Section III.

In the event that the water charge is not paid within fifteen (15) days of the billing date, the user shall be charged a five percent (5%) penalty.

SECTION IV.

In the event that the water charge is not paid within twenty-five (25) days of the billing date, a penalty of ten percent (10%) per annum, of five-sixths (5/6) of one percent (1%) per month, of the monthly water charge shall be assessed in addition to the above stated penalty.

SECTION V.



SECTION VI.


All prior ordinances conflicting with this Ordinance are hereby repealed.

ORDAINED AND ENACTED into law this 15 day of January, 2007.


