

ORDINANCE NO. 08-01

AN ORDINANCE OF THE BOROUGH OF TARENTUM, ALLEGHENY COUNTY, COMMONWEALTH OF PENNSYLVANIA AMENDING ORDINANCE 86-5 AND CHAPTER 250 OF THE TARENTUM CODE WHICH PRESCRIBES TRAFFIC AND PARKING REGULATIONS, LIMITS TRUCK WEIGHTS ON CERTAIN STREETS AND ALLEYS, PROVIDES PENALTIES FOR VIOLATIONS AND WHICH CODIFIES CERTAIN EXISTING TRAFFIC AND PARKING REGULATIONS, WHICH AMENDMENT CHANGES PARKING REGULATIONS AND ADDS STOP SIGNS IN THE BOROUGH.

WHEREAS, the Mayor of the Borough of Tarentum has declared an emergency requiring stop signs being placed East at the intersection of Oak Alley at Ormond Street and West at the intersection of Oak Alley and Fentzel Alley; and

WHEREAS, Council of the Borough of Tarentum, Allegheny County, desires to amend Ordinance 86-5 and Chapter 250 of the Tarentum Code for the purposes of public safety and to alleviate emergency conditions; and

WHEREAS, the intersections of Oak Alley and Ormond Street and Fentzel Alley have been identified as unsafe; and

WHEREAS, Council of the Borough of Tarentum has determined that a two hour parking restriction is no longer necessary at certain streets within the Borough of Tarentum; and

WHEREAS, Borough of Tarentum has determined that more restrictive parking would better serve the health, safety and welfare of the Borough of Tarentum at other streets within the Borough;

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of Tarentum Borough, and it is hereby ordained and enacted by authority of the same;

I. SECTION 22 of Chapter 250 of the Tarentum Borough Code is hereby amended to:

- A) add a stop sign going East on Oak Alley at the intersection at Ormond Street.
- B) add a stop sign going West on Oak Alley at the intersection at Fentzel Alley.

II. SECTION 26 of Chapter 250 of the Tarentum Borough Code is hereby amended to eliminate two hour parking restrictions at the following streets:

- 1) Worth Street from 3rd Avenue to 4th Avenue
- 2) McKee Street from 3rd Avenue to 4th Avenue
- 3) 3rd Avenue from Allegheny Street to Corbet Street
- 4) Allegheny Street
- 5) 4th Avenue from the east end of the Borough of Tarentum parking lot to Allegheny Street
- 6) Hickory Alley from 4th Avenue to 5th Avenue
- 7) East 8th Avenue from Ross Street to Wood Street
- 8) West 7th Avenue
- 9) Nothing in this Section 26 shall amend Section 25.

III. **SECTION 27** of **Chapter 250** of the Tarentum Borough Code is hereby amended to add the following Sub-Sections:

H. Parking shall be limited to 15 minutes from the cross walk at First National Bank on the North Side of East 6th Avenue to Lock Street.

I. Parking shall be limited to 30 minutes on both sides of 5th Avenue from Lock Street to 209 5th Avenue.


IV. **SECTION 25** of **Chapter 250** of the Tarentum Borough Code is hereby amended to prohibit parking at all times:

At the South side of 2nd Avenue from Bridge Street to the Brackenridge Borough line.


