**ORDINANCE NO. 08-02**

**AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF TARENTUM, ALLEGHENY COUNTY, PENNSYLVANIA, ESTABLISHING NEW RATES FOR ELECTRICITY FOR RESIDENTIAL, GENERAL SERVICE AND GENERAL POWER AND REPEALING ALL OTHER ORDINANCES THAT CONFLICT WITH THIS ORDINANCE.**

**WHEREAS**, the existing contract for the purchase of bulk electricity between the Borough of Tarentum and Dominion Power expires on March 31, 2008; and

**WHEREAS**, the Borough of Tarentum has made every effort to obtain bid proposals from electric suppliers for a bulk rate for the purchase of power over the last half year; and

**WHEREAS**, the lowest bid for power received is from PPL EnergyPlus; and

**WHEREAS**, April 1, 2008, the Borough of Tarentum will have to pay more for its bulk electricity purchased from PPL EnergyPlus; and

**WHEREAS**, the Borough's rate consultant engineer has designated rates sufficient to cover increased costs; and

**WHEREAS**, Council of the Borough of Tarentum is desirous to bill its customers and residents the least amount necessary to cover the increased costs applicable to the sale of electricity to the Borough customers.

**THEREFORE, BE IT ORDAINED AND ENACTED** by the Borough Council of the Borough of Tarentum and it is hereby ordained and enacted by authority of the same that Ordinance No. 02-02 is specifically amended as follows:

**SECTION I.**

**13.1 Residential Services Rate Schedule (RS)**

Subsection A. Monthly Rate.

The monthly customer charge shall be	\$5.00.
All KWH shall be billed @	11.34 cents/KWH.

**13.2 General Service Rate Schedule (GS)**

Subsection A. Monthly Rate.

The monthly customer charge shall be	\$10.00
All demand KW in excess of 5 KW shall be billed @	\$5.00 per KW
The first 300 KWH shall be billed @	15.84 cents per KWH
The next 700 KWH shall be billed @	10.04 cents per KWH
All excess KWH shall be billed @	9.54 cents per KWH

**13.3 General Power Rate Schedule (GP)**

Subsection A. Monthly Rate.

The monthly customer charge shall be	\$25.00
All KW shall be billed @	\$3.50 per KW
All KWH shall be billed @	9.20 cents per KWH

**SECTION II.**

All KWH charges billed, under each Customer Rate listed in Section I, will be increased or decreased, monthly, by the Purchased Power Adjustment (PPA)


**SECTION III.**


This new rate schedule for residential service, general service, and general power will become effective April 1, 2008.

**SECTION IV.**


All prior ordinances and/or resolutions or sections thereof conflicting with this Ordinance are hereby repealed.
