Also, the President of the Borough Council be authorized and directed to sign a Utility Reimbursement Agreement on its behalf and that the Secretary be authorized and directed to attest the President of Council's signature on the Utility Reimbursement Agreement for this highway project.

Cost Sharing Request Letter for Prior Work (Pilot 2)

Dear Sir or Madam:

This correspondence is submitted in accordance with Chapter 8.1.C of Design Manual Part 5, Utility Relocation, for referral to the Secretary of Transportation.

The proposed Highway Improvement Project of State Route SR0366 Sec A06, A07 and A08, located in the Tarentum Borough, Allegheny County requires the relocation and/or adjustment of electric facilities owned by the Borough of Tarentum.

It is understood that the cost of relocating and/or adjusting our said facilities are normally at our cost and expense, but that under the provisions of Section 412.1 of the Act of June 1, 1945, P. L. 1242, as amended (36 P.S. 670-412.1), the Secretary of Transportation may determine that the Department will share in such costs.

Accordingly, it is hereby requested that the Department of Transportation share in the costs of the relocation and/or adjustment of our electric facilities.

The Borough of Tarentum hereby offers to pay 25.00 per centum of the actual cost to relocate and/or adjust our electric facilities, provided the Department of Transportation will share in the balance of the actual cost thereof, less any betterment.

Furthermore, the Borough of Tarentum hereby agrees to execute an Agreement prepared by the Department of Transportation with such terms and conditions as the Secretary may deem necessary and advisable.

If the Secretary of Transportation accepts our offer and determines that the Department will share in 75.00 per centum, the Borough of Tarentum hereby agrees to provide the information by the accelerated dates listed below:

- The justification for utility impacts no later than the agreed upon date of December 22, 2017.
- The utility relocation plans, specifications and estimate/agreement package no later than the agreed upon date of February 24, 2018.
- The signed agreement to the Department not later than the agreed upon date of March 30, 2018.
- The physical relocation of our facilities by no later than May 30, 2018.

The Borough of Tarentum recognizes and accepts that failure to meet the above state milestones may result in the Department reducing its share to 0.00 per centum or 0% of the actual cost to relocate and/or adjust our electric facilities. However, if the Borough of Tarentum can recover from a missed milestone date without delaying the project letting, the Department will still cost share for 25%.

Attached hereto and made a part hereof is an executed Resolution authorizing the Borough of Tarentum to make the within offer.
