

## RESOLUTION #18-25

RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA AUTHORIZING AND APPROVING BUILDING INSPECTION AND PERMIT FEES.

**WHEREAS**, the Council of the Borough of Tarentum recognizes its employees, office staff and tax collector are called upon to perform numerous services the request of various interested individuals each day; and

**WHEREAS**, Section 1201 of the Borough Code, 8 Pa.C.S. §1202, entitled "Specific Powers" authorizes Borough Council the authority to establish fees.

**NOW, THEREFORE**, BE IT RESOLVED, by the Council of the Borough of Tarentum, Allegheny County, Pennsylvania and it is hereby resolved and enacted by and with the authority of same that the building permit and inspection fees be amended as described below; and

**BE IT FURTHER RESOLVED**, all fees must be paid at the time of application; and

**BE IT FURTHER RESOLVED**, these fees may be changed from time to time by resolution of the Council of the Borough of Tarentum; and

**BE IT FURTHER RESOLVED**, that this Resolution shall supersede all previously adopted fee resolutions inconsistent herewith.

Occupancy Inspection/Permit Fees	
Residential Inspection – Initial Inspection	\$75.00
Residential Re-inspection – First occurrence	\$25.00
Residential Re-inspection – Second occurrence	\$100.00
Residential Re-inspection – Third occurrence	\$150.00
Residential Re-inspection – Additional	\$200.00




