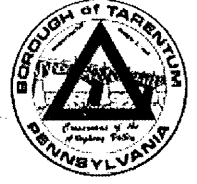

RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA AUTHORIZING THE DESTRUCTION OF SPECIFIC RECORDS PURSUANT TO THE MUNICIPAL RECORDS ACT.

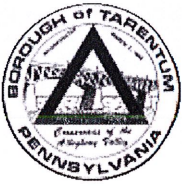

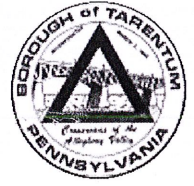


