RESOLUTION #19-21

RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA AUTHORIZING THE ESTABLISHMENT OF A PROCEDURE GOVERNING THE SALE OF PERSONAL PROPERTY VALUED AT LESS THAN ONE THOUSAND DOLLARS (\$1,000).

WHEREAS, section 1201.2 (a) of the Borough Code authorizes the Council of Tarentum Borough to establish a procedure for the sale of the surplus personal property which has an estimated value of less than \$1,000; and

WHEREAS, the Council of Tarentum Borough now desires to establish such a procedure.


NOW, THEREFORE, BE IT RESOLVED, that the Council of the Borough of Tarentum hereby authorizes the borough manager to sell the personal property of the Borough which has an estimated value of less than One Thousand Dollars (\$1,000) pursuant to the following procedure.

1. The borough manager may determine the value of the subject personal property (the "property") by obtaining from a vendor dealing in the Property, or goods substantially similar to the Property, in their regular course of business.
2. The lowest estimate shall constitute the minimum permissible sale price for the Property (the "Minimum Price").
3. The borough manager may then solicit and accept written offers of purchase at a price in excess of the Minimum Price (individually referred to as a "Purchase Offer").
4. After three (3) consecutive business days following receipt of the most recent Purchase Offer, the borough manager may accept the highest Purchase Offer received to that date and sell the property with or without approval of council. In the alternative, the Borough Manager may reject "any Purchase Offers or other offers at any time.
5. The borough manager shall report such sale at the Council Meeting immediately subsequent to such sale.


