ORDINANCE OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, FIXING THE LEVELS OF EMPLOYEES OF ALL DEPARTMENTS OF THE BOROUGH OF TARENTUM AND THE RATES OF COMPENSATION THEREOF FOR CALENDAR YEAR 2020.

WHEREAS, the Council of the Borough of Tarentum is duly empowered under the terms of the Borough Code to enact Ordinances fixing the status and levels of employees of the Borough of Tarentum and the rates of their compensation; and

WHEREAS, the Council of the Borough of Tarentum believes that it is necessary to adopt a specific Ordinance, which fixes the levels of all employees in all Departments of the Borough of Tarentum and the rates of their compensation for calendar year 2020.

WITH THE FOREGOING RECITALS INCORPORATED HEREIN BY REFERENCE THERETO, THE COUNCIL OF THE BOROUGH OF TARENTUM HEREBY FIXES THE STATUS AND LEVELS OF EMPLOYMENT OF ALL DEPARTMENTS OF THE BOROUGH OF TARENTUM AND SETS THE RATES OF THEIR COMPENSATION FOR THE CALENDAR YEAR 2020 AS FOLLOWS:

Specifically, this Ordinance incorporates herein the “Tier Wage System” form of compensation of new full-time patrolmen having less than six (6) years’ experience.
