## ORDINANCE #21-03

ORDINANCE OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, PROHIBITING CERTAIN ACTIVITIES AND CONDUCT ON BOROUGH PROPERTY.

**WHEREAS**, the Council of the Borough of Tarentum strives to protect the health, safety and welfare of our citizens and community; and

**WHEREAS**, the Council of the Borough of Tarentum recognizes that various activities may take place on Borough owned property that are a benefit to the community; and

**WHEREAS**, the Council of the Borough of Tarentum desires to protect the rights of our community for the quiet and peaceful enjoyment of Borough owned parks and property while recognizing that certain limited, authorized use of Borough property and parks for approved special events will also serve the interests of our community.

**NOW, THEREFORE**, BE IT ORDAINED AND ENACTED by Council of the Borough of Tarentum, and it is hereby ordained and enacted by authority of same as follows:

### 1. PURPOSE

The purpose of this Ordinance is to amend, consolidate and/or replace existing legislation regarding alcohol consumption on borough property which includes provisions detailed in Tarentum Borough Code Chapter 177 Parks and Recreation, Article II and Chapter 200 Riverview Memorial Park.

### 2. DEFINITIONS

“Borough Property” shall mean any property titled in the name of Tarentum Borough and all publicly maintained areas and rights-of-way located within the Borough.

### 3. PROHIBITED ACTS.

Consumption of alcohol on Borough property including parks, play areas, sport areas, trails and Borough maintained rights-of-way is prohibited unless specifically approved in advance by Tarentum Borough.

### 4. NOTICES

The borough may post notices at each of its properties informing the public of the provisions of this article and of the fines for violation of the same.

### 5. PENALTIES

It shall be unlawful for any person to violate the provisions of this Ordinance. Any person violating the provisions of this Ordinance shall be guilty of a summary offense and, upon conviction before a Magisterial District Judge having jurisdiction over same, be sentenced of a fine of not less than three hundred dollars (\$300) and, in default of payment thereof, be sentenced to the maximum punishment provided for summary offenses under Pennsylvania Law.


### 6. REPEALER & SEVERABILITY


All Ordinances or parts of ordinances which are inconsistent herewith are hereby repealed. The provisions of this Ordinance are severable. In the event any term or provision of this amendment are held to be void or invalid, the remaining provisions of this Ordinance shall remain in full force and effect.


