ORDINANCE NO. 07-11

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF TARENTUM, ALLEGHENY COUNTY, PENNSYLVANIA, DESIGNATING THE RATES FOR TRASH, RUBBISH AND GARBAGE COLLECTION FOR RESIDENTS OF THE BOROUGH OF TARENTUM AND ESTABLISHING A TEN PERCENT (10%) LATE PAYMENT PENALTY AND REPEALING ALL OTHER ORDINANCE IN CONFLICT WITH THIS ORDINANCE.

WHEREAS, the Council of the Borough of Tarentum desires to designate its charge for trash, rubbish and garbage collection; and

WHEREAS, contracted costs for same have increased through the year 2008; and

WHEREAS, the Council of the Borough of Tarentum desires to establish a ten percent (10%) per month late payment penalty on the total balance due for garbage collection and an additional five percent (5%) per month non-payment service charge.

THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Borough of Tarentum and by the authority of the same.

SECTION I.

The rates for trash, rubbish and garbage collection to residential customers of the Borough of Tarentum effective January 1, 2008, are hereby established as follows: \$17.00 per month.

SECTION II.

The rates for trash, rubbish and garbage collection to Commercial customers of the Borough of Tarentum, effective January 1, 2008, are hereby established as follows: \$25.00 per month, unless the customer has a collection contract with a private hauler.

SECTION III.

In the event that the above referenced collection charge of \$17.00 or \$25.00 per month is not paid within fifteen (15) days of the billing date the residential or commercial customer shall be charged the additional five percent (5%) per month non-payment service charge.

SECTION IV.

In the event that the above referenced collection charge of \$17.00 of \$25.00 per month is not paid with twenty-five (25) days of the billing date, the customer shall be charged a ten percent (10%) per annum or five-sixths (5/6) of one percent (1%) per month of the \$17.00 or \$25.00 monthly charge in addition to the above referenced service charge.

SECTION V.

The proper officers of the Borough of Tarentum are authorized and directed to take whatever steps are necessary to affect this change in rates and said officers are authorized to give notice of said change to the customers of the Borough of Tarentum.

SECTION VI.

All prior ordinances and/or resolutions or sections thereof conflicting with this Ordinance are hereby repealed.
