# SEPTEMBER 2018 Executive Director's Report

The following items of special interest were processed since last month's meeting:

- 1.) Federal Community Development Block Grant (CDBG) Program Year 43/FY 2017Program Update. All of our twelve CDBG Year 43/FY 2017 projects are now completed; with submissions of final paperwork and cost reports for two projects being filed.
- FY 2018 Bid Cycles. Allegheny County Economic Development's (ACED) 2018 Final Annual Action Plan was submitted to HUD on May 15, 2018. CDBG Yr. 44 Award (and non-funding) Letters for the participating COG members were received and distributed electronically on June 15, 2018 to the respective municipal secretary/managers, their engineer's of record, and the COG Board members. A one-time additional CDBG grant award to Allegheny County of approximately \$1M (from which approximately \$800K in project grants would be available) was made possible by a \$300M increase in CDBG funding for this year that yielded one additional funded project, for a total of fourteen (14) CDBG projects this program year. As has been the case for the last several years, since the return to the July-August program year, the bid cycles for CDBG Yr. 44/FY 2018 had a bid opening in late August & will have the second on October 1, 2018.

The <u>Initial Bid Cycle's opening was held on Monday</u>, <u>August 27<sup>th</sup></u>; due to the fact the fact that the COG Board would not meet in August, the Board passed a resolution at the July 2018 meeting to award to the lowest responsible bidder for each of the seven projects scheduled to open that date, as determined by the participating members' governing body, at the recommendation of their consulting engineers, and in consultation with their solicitors. At this month's meeting, the actual bid results are reported to the Board below, and in compliance with the action of the participating members, the Board's confirmation of those awards made will be sought tonight.

We encouraged our members, therefore, to carefully consider all possible CDBG applications for submission this fall. It is true there are engineering costs in the preparation of applications, and time & effort required from the municipal staff, particularly if household surveys are required to document eligibility. We did see an increase in Pre-Applications filed this year, from eighteen last year, to twenty-five this year, a nearly forty percent increase!

Changes for CDBG Year 45/FY 2020 Application Process. As was reported in June, the County secured private foundation funding, including the Heinz Foundation, for an effort to make the CDBG application process available completely on an "on-line basis," referred to a "digital transformation."

The COG Directors requested several additional functions for the CDBG webform/application that are crucial for the efficient and effective use of the new format. Due to the amount of the information required for the CDBG application, and the complexity associated with obtaining the information, the COG members have requested an alteration to the Client Login and User Account design. Specifically:

- a "Master Account" would be created for each COG;
- this account will be permitted to create Sub-accounts for specific users; and
- this would allow engineers and other specified users to update the open application.

It was initially felt these changes would not happen immediately, possibly not until CDBG Year 46/FY 2020; but it was announced, in July, that the on-line (full) CDBG Application, would be implemented this fall in the CDBG Program Year 45/FY 2019 Application process. The Pre-application submissions, while utilizing a "fill-able" application form, were not completed on-line. The were required, however, to be submitted electronically to the COGs for review, then, in turn, submitted by e-mail to the Allegheny County Economic Development (ACED) department.

However, a special, on-line training session was held by ACED regarding the new Full On-Line CDBG Application was held on September 14, 2018, and it appears that the on-line application process will, in fact, proceed this year.

### 3.) Status of 2018 Gaming & Economic Development Fund (GEDF) \$250K

Grant to the AVNCOG for Paving & Associated Equipment. The COG Board approved a slate of five (5) specific pieces of paving and related equipment for purchase through the awarded GEDF grant of \$250,000 which were made as "piggy-back" acquisitions through several state purchasing programs, including COSTARS. As this deviates from the GEDF program's procurement guidelines, approval as sought and granted by ACED.

Stephenson Equipment, Inc., has acted as our equipment purchasing agent. The purchase orders were presented to the Board at June's meeting, but as the executed grant contract was not returned to the COG until mid-July, they were not placed until July 31st. Also a formal request for a waiver from the GEDF procurement protocol requiring the re-imbursement of payments to be made initially by the grantee to the contractor, was also submitted shortly after the contract was received.

Several weeks after the trailer order was placed, however, it was discovered that the planned vendor had withdrawn from the manufacture of custom constructed heavy equipment trailers. An alternative manufacturer was engaged, but the trailer will not be available for delivery until after the new year; therefore that paver and roller will not be transported to the Allegheny Valley until that time. The other pieces of equipment have been received by Stephenson Equipment, and it is anticipated that delivery will be arranged to the local storage facilities for the skidster (bobcat) and it's attachments this fall, and training opportunities will be scheduled. Training on the paver and roller will follow in the spring.

6.) CDBG Year 45/FY 2019 Application Cycle. As was noted at the early summer meetings, the application dates for CDBG Year 45/FY 2019 were expected to mirror those established since the program year was shifted from March-thru-February to July-thru-June, and this, in fact, did occur. Thus, as you may be aware, pre-applications were submitted on September 14, 2018, and full Applications will be due by November 16, 2018.

The COG's communities did well in garnering CDBG funding for CD Yr. 44, with nearly 80% of applications funded, as Mr. Taliani noted. That is due, in part, however, to the drop-off in CDBG applications submitted for consideration. It is a phenomenon that many of the COGs have witnessed.
