VETO WAS NOT OVER-RIDDEN BY COUNCIL AT December 12, 1983 MEETING.

Declaring that official stop signs are to be erected at the intersection of First Avenue and Lock Street for a trial period of ninety (90) days, and amending for ninety (90) days any inconsistent ordinance for the trial period.

Accepting the proposal of the Southwest National Bank of Pennsylvania to purchase a note of the borough of Tarentum and awarding to said bank a non-electoral general obligation note; for the Water Plant Improvement establishing a sinking fund and appointing a sinking fund depository; designating the proper officers of the Borough to execute and deliver note; certify and file the debt statement and to apply for approval of the loan and to contract with the sinking fund depository.
