2019-2020 Legislative Session Underway

A new two-year legislative session began this month with the swearing-in of the new and re-elected members of the General Assembly, the Governor and the Lt. Governor. There are a record 49 freshman legislators this term. There is also a record number of 63 women serving. While republicans remain in the majority, democrats gained seats in both Chambers.

Leadership in the House and Senate has largely remained unchanged. One exception, a new House Majority Leader has been named -- Bryan Cutler from Lancaster County. There are a number of changes in committee chairs. Most notably for local government, there is a new majority chair for House Local Government -- Dan Moul of Adams County. Bob Freeman, Northampton County will continue as minority chair. The Senate Local Government Committee will now be chaired by Scott Martin of Lancaster County and freshman senator Tim Kearny of Delaware County.

The League's governmental affairs staff is tracking co-sponsorship memos and bills as they are introduced. Our <u>2019 Legislative Priorities</u> are complete and we will use them as a starting point in meetings with legislators.

• Community safety grants available to municipalities, colleges, community-based organizations — local municipalities, colleges and community groups should apply for these grants to boost safety and reduce the risk of violence. The grants are part of a new program included in this year's state budget to improve school safety and combat community violence. A total of \$7.5 million will be awarded statewide during this fiscal year to support community violence prevention programs. Applications accepted until February 7.



- As Federal Government Remains Mired in Shutdown, 20+ City Leaders Convene in Washington to Find Solutions to Nation's Housing Crisis As the federal government enters into the second month of a partial shutdown, more than 20 leaders from America's cities, towns and villages gathered in Washington to take action to solve one of the toughest challenges facing the nation: the housing crisis. The National League of Cities (NLC) National Housing Task Force held its inaugural meeting, ratifying five policy priorities that will be key to addressing the national housing crisis in 2019. - Waters of the United States (WOTUS) Webinar February 4 at 1 p.m. (EST), hosted by the National Association of Counties. "Waters of the United States" is a controversial regulatory term used in the Clean Water Act (CWA) to define the geographic scope of federal jurisdiction over rivers, lakes, streams, wetlands, and other aquatic features. The U.S. Environmental Protection Agency and the U.S. Army Corps of Engineers recently proposed a new regulation that seeks to withdraw the 2015 definition finalized during the Obama Administration and replace it with a new and narrower definition of "waters of the United States." The public comment period on this proposed rule will be opening soon and Samuel Brown, a partner with Hunton Andrews Kurth LLP and a former attorney with the U.S. Environmental Protection Agency, will provide a summary of the proposed regulation and the potential practical implications on state and local governments.
