Local Use of Radar Moves to the Full House


Senate Bill 607 was amended this week in the House Transportation Committee and voted out to the Full House. Several changes have been made to the bill. The most significant is that the bill limits the use of Radar or LIDAR to full-service departments and full-time officers. The League supported the amendment believing it was best to get the bill out of Committee. The issue of use by part-time departments and part-time officers will most likely be debated on the House Floor. All indications are that the bill will continue to move toward the Governor's desk. • Newly Elected Official Affidavits of Residency — Prior to taking the Oath of Office, each newly elected official in a third class city, borough, or first class township, must present a signed affidavit to the city clerk, secretary, or manager attesting to continuous residency for one year preceding the individual's election. This affidavit is a qualification for office. Click here to see the sections of



<u>codes</u>. Each municipality should reach out to its newly elected officials and provide notice of this requirement well in advance of January's swearing-in ceremonies. <u>Click here for a sample residency affidavit</u>. Your solicitor should approve prior to its use.

- The U.S. Environmental Protection Agency (EPA) announced that \$1.5 million in competitive grants will be awarded to 50 organizations working to address environmental justice issues in their communities. Read the press release here.
- Governor Wolf Announces Veterans' Trust Fund Grant Opportunities The Veterans' Trust Fund (VTF) is accepting grant applications for programs and services benefiting Pennsylvania veterans. The Department of Military and Veterans Affairs (DMVA) will award up to \$800,000 in VTF grants to non-profit organizations, veteran service organizations and county directors of veteran affairs across the state.
