# Borough of Tarentum Regular Council Meeting MAY 3<sup>RD</sup> 2016

Call to order/ pledge allegiance

Roll call-all in attendance

Motion: Councilman Varos 2<sup>nd</sup> Councilwoman Fox, to approve April 5th council meeting minutes. Motion passed.
