**COMMERCIAL REVITALIZATION-RESOLUTION OF COUNCIL**

RESOLUTION OF THE BOROUGH OF TARENTUM CONFIRMING BOROUGH OF TARENTUM PLANNING COMMISSION RESOLUTION NUMBER 10-05 AND AUTHORIZING THE BOROUGH OF TARENTUM TO REQUEST COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING FOR THE ELIMINATION AND PREVENTION OF BLIGHT IN A DESIGNATED AREA.

WHEREAS, the Planning Commission of the BOROUGH OF TARENTUM has certified a particular area as blighted or containing inadequacies which lead to blight, within the meaning of the Urban Development Law of 1945, P.L. 991, as amended, a description of which is attached (Exhibit A);

AND

WHEREAS, the BOROUGH OF TARENTUM Has examined the designated area and reviewed "EXHIBIT A", and concurs with the Planning Commission Resolution Number 10-05;

AND

WHEREAS, the BOROUGH OF TARENTUM desires to request Community Development Block Grant Funding assistance from the Department of Economic Development, Allegheny County, Pennsylvania, to implement a plan of improvements for the elimination and prevention of blight;

AND

WHEREAS, the BOROUGH OF TARENTUM desires to retain the ALLEGHENY VALLEY NORTH COUNCIL OF GOVERNMENTS a non-profit organization existing under the laws of the Commonwealth of Pennsylvania, as the official agency to request Community Development Block Grant Funding Assistance;

AND

WHEREAS, the BOROUGH OF TARENTUM desires to undertake the development of said area in order to eliminate or prevent blight by providing a more suitable environment for all project area residents.

NOW, THEREFORE, BE IT RESOLVED by the BOROUGH OF TARENTUM as follows:

1. That it is hereby found and determined that the area designated on "EXHIBIT A" is a blighted area, or contains inadequacies which lead to blight, and qualifies as an eligible development area under the Pennsylvania Urban Redevelopment Law 1945, May 24, P.L. 991, as amended;

AND

2. That the BOROUGH OF TARENTUM is hereby approved as the official agency to administer the development in the designated area;


