## RESOLUTION #20-15



RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA AUTHORIZING THE FILING OF AN APPLICATION FOR CDBG FUNDS WITH ALLEGHENY COUNTY ECONOMIC DEVELOPMENT, DESIGNATING AN OFFICIAL TO PERFORM REQUIRED DUTIES, AND PROVIDING ASSURANCES FOR LOCAL MATCHING FUNDS.

**WHEREAS**, the Borough of Tarentum, County of Allegheny, Commonwealth of Pennsylvania, desires to obtain funds from Allegheny County Economic Development in the amount of \$36,036 under the Federal Housing and Community Development Act of 1970, as amended;

**NOW, THEREFORE**, BE IT RESOLVED, that the Borough of Tarentum of Allegheny County hereby formally requests CDBG funds from Allegheny County Economic Development for the Tarentum Borough Manhole Rehabilitation Project.

**NOW, THEREFORE**, BE IT FURTHER RESOLVED, that the Borough of Tarentum does hereby designate Thomas J. Benecki, Executive Director of the AVNCOG (the "Authorized Official") as the official to file all applications, documents and forms between the Borough of Tarentum and Allegheny County Economic Development.

**NOW, THEREFORE**, BE IT FURTHER RESOLVED, that the Borough of Tarentum assures, where applicable, the provision of the full local share of the project costs.

**NOW, THEREFORE**, BE IT FURTHER RESOLVED, that the Borough of Tarentum assures, that the project will be awarded or under construction within 180 days after contractual execution.
