ORDINANCE #21-05

ORDINANCE OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING PARKING TIME LIMITATIONS IN SPECIFIC LOCATIONS FOR SPECIFIC DAYS AND HOURS; DEFINING PARKING, UNLAWFUL PARKING; POSTING OF PARKING TIMES OR OFFICIAL SIGNS; SCHEDULE OF FINES AND PROVIDING FOR THE ENFORCEMENT OF THIS ORDINANCE AND THE PENALTIES FOR VIOLATION THEREOF TOGETHER WITH THE REPEAL OF ANY ORDINANCES INCONSISTENT HERewith.

WHEREAS, the Council of the Borough of Tarentum, County of Allegheny, Commonwealth of Pennsylvania further desires to promote the health, safety and welfare of the residents of the Borough; and has Health, Safety and Welfare for its citizens as a primary concern; and

WHEREAS, the Council of the Borough of Tarentum wishes to revise, restate and ordain the provisions and standards for vehicular parking within Tarentum Borough.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by Council of the Borough of Tarentum, and it is hereby ordained and enacted by authority of same as follows:

1. LOCATIONS

It shall be unlawful for the owner or operator of any vehicle to park such vehicle, between the hours of _____, Monday to Sunday, for more than two hours at any one time upon the portion of streets or parking lots where parking is permitted by **Ordinance 86-5** designated as follows:

- Tarentum Borough Parking Lot having Parcel ID 1223-M-00312 situated on the 300 Block between East 4th Avenue and East 5th Avenue.
- Tarentum Borough Parking Lot having Parcel ID 1223-M-00315 situated at 0 Station Drive more commonly known as the "Train Station Parking Lot."
- Tarentum Borough Parking Lot having Parcel ID 1223-M-00377 situated on or about 411 East 6th Avenue more commonly known as the "6th Avenue Parking Lot"

2. SIGNAGE

Borough shall install signage as follows:

3. PENALTIES

It shall be unlawful for any person to violate the provisions of this Ordinance. Any person violating the provisions of this Ordinance shall be fined \$_____ per violation and, if in default of payment thereof, subject to prosecution for a summary offense under Pennsylvania
