MINUTES of the APRIL 28, 2021 MEETING of the BOARD of DIRECTORS

I. CALL TO ORDER

President Taliani called the meeting of the AVNCOG to order at 7:00 pm with the Pledge of Allegiance.

IV. APPROVAL OF MINUTES

President Taliani reported that the March 2021 minutes had been forwarded to the Board for review and asked for the wish of the Board. **Ms. Fox** moved to accept the minutes as written. Seconded by **Mr. Connelly,** and carried unanimously.

V. FINANCIAL REPORT AND BILLS

President Taliani asked for a motion to pay the Regular Bills for April, 2021 as listed. Ms. Fox moved to pay all bills as presented. Seconded by Mr. Connelly and carried unanimously.

VI. REPORT OF THE EXECUTIVE DIRECTOR

The following items of special interest were processed since last month's meeting:

1.) <u>CDBG Program Year 47/FY 2021's Consolidated Plan Release</u>. Twenty-two (22) full Applications were submitted to the Allegheny County Economic Development (ACED) by the COG last November. The CDBG Program Yr. 47/FY 2021 Allegheny County Annual Plan, was released to the COGs on April 15, 2021, listing an expected CD 47/FY 2021 CDBG allocation to

Allegheny County of \$13,878,721.

At the current time, however, ACED has not released a detailed listing of the individual project funding awards by individual COGs, municipalities or authorities, as has long been the ACED's custom. Only summary categorical funding allocations (e.g.: for Public Improvements (improvements to streets, sidewalks and stormwater infrastructure): \$934K; for Water & Sewer: \$1.81M; for Parks & Recreation: \$80K; for Safe Neighborhoods Demolition: \$432K; for COG Administration: \$373K; for Removal of Architectural Barriers: \$451K; for Business Development: \$700K; and, for the Allegheny Together program: \$750K) were released, and from which the individual municipal projects have been awarded in the past. Therefore, a summary sheet of the AVNCOG's individual, funded projects by municipality is not yet available.

I have spoken to the other COG Directors, all who similarly received no such break-out e, and also asked our COG Representative, as well the ACED's CDBG SND & Blight Removal Programs manager about the change (as the SND awards would impact the Act 152 application grant requests), but no specific reply has yet been received in the two weeks since the Action Plan was released.

2.) 2021 Community Infrastructure & Tourism Fund (CITF) Applications.

Of the 12 applications submitted by the AVNCOG for the 2021 Community Infrastructure & Tourism Fund (CITF) application round, which was put together to expend approximately \$2.5M in unexpended funds from the original 12-yr. program run, the funding of two projects was announced earlier this month. 3.) PA Act 152 of 2016: Blight Removal Program's initial Application round closes this Friday, April 30, 2021. The initial 2021 application round opened on March 10th and closes this Friday, April 30th. On March 9, 2021, PDF files containing a "fillable" application form (for submission through the Allegheny Valley North COG with the COG as the applicant) & pertinent guidelines for the initial 2021 ACT 152 Blight Removal Program, provided through the Allegheny County Economic Development (ACED) department, were distributed to all members by the AVNCOG.

In addition to demolition, the program will be funding Blight Removal/Feasibility Studies and Asbestos Surveys. The program imposes a \$15K minimum grant, and \$250K maximum grant, with a prevailing wage requirement for all grants above \$25K. Additionally, a provision for "Emergency Demolitions" is contained in the program, and detailed in the slides. A new- and unique- requirement will be imposed by the program: **Lead Safe Demolition**, which includes the practice of "lead safe demolition," including required pre-demolition notification of residents. All demolitions must utilize "wet-wet-wet techniques."

4.) American Rescue Plan (ARP) Municipal Funding. As you are aware, the ARP provides \$360B in funding to state & local governments. Pennsylvania state government and it's

local governments will receive approx. \$13.7B in total funding, with just over half of it going to the state government itself. Of the \$5.2B going to cities, counties and local governments, \$936M will go to the state's local governments (non-city/county units). The funding spreadsheet posted on the U.S. House Oversight Committee's website, filtered to include just the municipalities of the Allegheny Valley North COG in Allegheny County, was distributed ahead of last month's meeting, and shows that our members will collectively receive \$3.85M. The states will receive the monies for all municipalities below 50K in population by May 10, 2021 and must then forward direct payments, the first of two parts, within a month of that date.

State and local funds under ARPA must be used for:

- responding to the COVID-19 public health emergency and its negative economic consequences, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;
- supporting essential workers;
- providing government services and offsetting revenue losses;
- necessary improvements to water, sewer, or broadband infrastructure.

Additionally, funds received by local or State governments may be transferred to nonprofit organizations or other jurisdictions to carry out eligible activities.

A copy of the article was distributed at last month's meeting.

At this point, no additional information has been released by the state as to the time table for releasing municipal funds to the membership, which are based upon population.
