RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA DESIGNATING THE RATES FOR METERED WATER SOLD BY THE BOROUGH TO ITS CUSTOMERS, INCLUDING THE TOWNSHIP OF EAST DEER AND REPEALING ALL RATES INCONSISTENT HEREWITH.

WHEREAS, the Borough of Tarentum, County of Allegheny, Commonwealth of Pennsylvania, is authorized under the Borough Code Section 3301.1 to adopt ordinances and resolutions for any purpose and as deemed beneficial to the borough, 8 Pa C.S. § 3301.1; and

WHEREAS, operational costs including labor, electricity, and raw chemicals and the continued updating and maintenance of the water treatment plant and its ancillary facilities to manufacture potable water have increased on a regular basis; and

WHEREAS, the Council of the Borough of Tarentum desires to designate and amend rates to sufficiently compensate for the current costs of water production; and

WHEREAS, the Council of the Borough of Tarentum desires to designate and amend rates for metered water sold to Tarentum Borough customers and to the Township of East Deer; and

WHEREAS, the Council of the Borough of Tarentum has previously ordained and enacted legislation that allows for water rate modifications to be approved by Resolution of Council.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Tarentum, County of Allegheny, Commonwealth of Pennsylvania, as follows:

The recitals set forth above are incorporated herein by reference.

SECTION 1: The rates for metered water shall be changed to read as follows effective January 1, 2022:

Size of Meter	Allowance in Gallons	Base Rate
5/8"	2,000	\$25.30
3/4"	3,000	\$29.79
1"	5,000	\$46.32
1 1/4"	9,000	\$75.92
1 1/2"	14,000	\$113.54
2"	23,000	\$182.93
3"	46,000	\$355.70
4"	92,000	\$682.26
6"	234,000	\$1,762.59

For all usage in excess of two thousand (2,000) gallons per month, the charge shall be \$8.21 per one thousand (1,000) gallons used.

SECTION 2: The quarterly bulk rates for metered water sold to East Deer Township shall be changed to read as follows effective May 1, 2022 for each metered connection:

Usage Per Quarter	Charges Per 1,000 Gallons
First 200,000 gallons	\$5.15
Next 200,000 gallons	\$4.79
Next 200,000 gallons	\$4.47
Next 200,000 gallons	\$4.17
Next 200,000 gallons	\$3.91

For all usage in excess of 1,000,000 gallons per quarter, the charge shall be \$4.65 per thousand (1,000) gallons used.

As of January 1, 2022, a flat rate of \$8.65 per one thousand (1,000) gallons of water shall hereinafter be charged to any bulk use customer, water hauler, or temporary use consumer at locations where a water meter must be temporarily installed. Any requests for this rate category must be approved in advance by the Borough Manager.

All prior Resolutions conflicting with this Resolution are hereby repealed.
