Benecki, Executive Director of the AVNCOG (the "Authorized Official") as the official to file all applications, documents and forms between the Borough of Tarentum and Allegheny County Economic Development.

**NOW, THEREFORE**, BE IT FURTHER RESOLVED, that the Borough of Tarentum assures, where applicable, the provision of the full local share of the project costs of \$107,468.00.

**NOW, THEREFORE**, BE IT FURTHER RESOLVED, that the Borough of Tarentum assures, that the project will be awarded or under construction within 180 days after contractual execution.
