RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, SUPPORTING THE CREATION OF A TAX BREAK FOR FIREFIGHTERS AND EMERGENCY MEDICAL SERVICES PERSONNEL.

**WHEREAS**, Tarentum Borough recognizes the sacrifices made by these individuals and the crucial role they play in maintaining public safety and emergency response preparedness; and

**WHEREAS**, it is a priority of Tarentum Borough to support the firefighters and EMS personnel who serve our community so selflessly; and

**WHEREAS**, providing a tax break to firefighters and EMS personnel is a tangible way to show appreciation and support for their essential services, and to assist in alleviating the financial burdens they bear;

**NOW, THEREFORE, BE IT RESOLVED**, that the Tarentum Borough hereby expresses its strong support for the creation of a tax break for firefighters and EMS personnel; and

**BE IT FURTHER RESOLVED**, that Tarentum Borough urges the County Council of Allegheny to enact legislation that would provide this tax relief to firefighters and EMS personnel; and

**BE IT FURTHER RESOLVED**, that a copy of this resolution be forwarded to the appropriate local officials and departments, to demonstrate the Borough's commitment to supporting the firefighters and EMS personnel who dedicate their lives to serving our community.
