RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, REQUESTING NORFOLK SOUTHERN RAILROAD COMPANY TO REPAIR ROADWAY AT CORBET STREET.

WHEREAS, the roadway directly beneath the rails at the Corbet Street intersection, which falls under the jurisdiction of the Norfolk Southern Railroad Company, has been experiencing significant deteriorating conditions; and

WHEREAS, the continued deterioration of this roadway poses a safety hazard to vehicular and pedestrian traffic, as well as potential disruptions to the operations of Norfolk Southern Railroad; and

WHEREAS, the repair and maintenance of this roadway are essential to ensuring the safety and well-being of the local community, as well as the efficient operation of the railway; and

WHEREAS, the Norfolk Southern Railroad Company has a responsibility to maintain the infrastructure under its control in a state of good repair;

NOW, THEREFORE, BE IT RESOLVED that the Borough of Tarentum hereby requests the Norfolk Southern Railroad Company to take immediate action to repair the roadway directly beneath the rails at the Corbet Street intersection; and

BE IT FURTHER RESOLVED that the Norfolk Southern Railroad Company is urged to prioritize this repair work to prevent further deterioration and to ensure the safety and convenience of all who use this roadway and railway; and

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the appropriate representatives of the Norfolk Southern Railroad Company, as well as to local and state officials, to emphasize the urgency and importance of this matter.
