What is our access going to be during paving? Mr. Boddorf noted that there will be single-lane restrictions so we can keep it as open as possible. The contract went to El Grande Industries.

Tom Kish (Brackenridge Borough), I would like to know now if we are not going to have a lease.

Walt Rotholtz 521 1st Avenue, we need to know what is going on. What happens if we just put our stuff there? Solicitor Dee noted you would be subject to some kind of legal suit. You can get an attorney and have that person call me.



Rhonda Rothholtz, 525 1st Avenue, I would like to know what the development plan is. Council President Dadowski stated we cited the comprehensive plan between Brackenridge, Harrison, and Tarentum, overwhelming wanted access to the river. In April, we listed the uphill battle to make what is going on down there legal. What is going on down there right now is not legal. For whatever reason, the permits did not get completed in 2016. Borough Solicitor Dee added the leases only go for a season. If one violates the lease and tries to use their violation of the lease to justify their position, that's not legally acceptable.

Scott Simmers, 175 Cedar Street, didn't we have to write a letter to the manager about leaving the docks? The Borough Solicitor stated I am quite confident you do not have the legal footing to stand on. The council will discuss this.

Bill Mayhew 347 West 11th Ave. How many engines for Mr. Kerr? Where do we stand with the Weleski signage? Mr. Boddorf noted a public hearing is coming up and you are welcome to come and make a comment.

Kyle Huffman, everyone is asking you for more time because they have more than docks to come out. Give us time or there will be one hell of a bonfire.

Jen Simmers 175 Cedar Street, do you have a plan in place to stop it from being completely overgrown and to stop homeless people?
