 Mr. Boddorf discussed setting a threshold for liens instead of doing them individually.
- Discussion on 2024 water rates and contract with East Deer. Mr. Boddorf noted that we had the DEP come in and do a voluntary audit in December. The water system is aging and failing. It is unsustainable, and we need to make a plan to replace so many feet per year. The DEP also provided a number of financial analyses. I would ask the Council to consider raising water rates and dropping the EPA fee as we look at the budget.

- Discussion Resolution for Fire Departments and DCED that will allow DCED to bring. in a specialist to help us plan future fire needs and services. We have three buildings that are 100 years old. The State can help us figure out how to appropriately care for the buildings and maintain service.


