A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF TARENTUM, ALLEGHENY COUNTY, PENNSYLVANIA, ESTABLISHING A BOROUGH GRANTS FUND TO SUPPORT THE ADMINISTRATION AND IMPLEMENTATION OF GRANTS RECEIVED BY THE BOROUGH.

WHEREAS, the Borough of Tarentum seeks to maximize funding opportunities through grants to support projects, programs, and services that benefit the community; and

WHEREAS, the Borough Council recognizes the need for a dedicated fund to manage grant monies separately from the Borough's General Fund to ensure transparency, proper accounting, and efficient administration of awarded funds; and

**WHEREAS**, establishing a Borough Grants Fund will facilitate the Borough's capacity to manage multiple grants from federal, state, and private sources while complying with applicable requirements and regulations; and

WHEREAS, the Borough Grants Fund will enable the Borough to track expenditures, document grant-related activities, and maintain accountability for all grant-related financial transactions;

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Tarentum, as follows:

- Section 1. Establishment of the Borough Grants Fund
   A Borough Grants Fund is hereby established as a separate and distinct fund from the Borough's General Fund, to be known as the "Borough Grants Fund."
- Section 2. Purpose of the Borough Grants Fund
  The Borough Grants Fund shall be utilized exclusively for the deposit of grant revenues and the
  payment of expenditures directly related to grant-funded projects or programs. This fund will
  support the proper financial management of funds awarded to the Borough of Tarentum from
  various grant sources.
- Section 3. Deposits to the Borough Grants Fund All revenues received from grants, including federal, state, local, and private grants awarded to the Borough, shall be deposited into the Borough Grants Fund upon receipt. Interest earned on funds in the Borough Grants Fund shall remain within the fund to support grant-related activities.
- Section 4. Appropriations and Expenditures
   Funds from the Borough Grants Fund may be appropriated and expended by the Borough solely
   for the purposes designated by each grant award, as specified by the terms and conditions of
   each

grant agreement, and in accordance with Borough policies and procedures.

- Section 5. Financial Oversight and Reporting
  The Borough's Administrative and Finance Officer shall be responsible for overseeing the
  financial management of the Borough Grants Fund. Regular financial reports of all receipts,
  expenditures, and balances shall be provided to the Borough Council to ensure compliance and
  transparency.
- Section 6. Severability

  If any provision, section, sentence, clause, or part of this Resolution shall be deemed invalid, such invalidity shall not affect or impair any remaining provisions, sections, sentences, clauses, or parts of this Resolution, it being the intent of the Borough Council that the remainder of this Resolution shall remain in full force and effect.
- Section 7. Effective Date
  This Resolution shall take effect immediately upon adoption.
