## RESOLUTION #24-32

RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA AUTHORIZING THE COST-SHARING AGREEMENT FOR EMS CONSULTANT FEES BETWEEN PARTICIPATING MUNICIPALITIES.

**WHEREAS**, the municipalities of Brackenridge, East Deer, Harrison, and Tarentum recognize the need for a consultant to assist in the development of solutions for emergency medical services (EMS) to ensure the continued health and safety of their residents; and

**WHEREAS**, the total cost for EMS consultant services shall not exceed Thirty-Two Thousand Five Hundred Dollars (\$32,500); and

**WHEREAS**, the cost of the consultant services will be equitably distributed among the participating municipalities based on their respective populations as follows:

- Brackenridge (Population: 3,240): \$5,473.26
- East Deer (Population: 1,490): \$2,517.02
- Harrison (Population: 10,157): \$17,157.99
- Tarentum (Population: 4,352): \$7,351.73

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of Tarentum Borough, as follows:

1. Authorization to Participate
  - a. Tarentum Borough agrees to participate in the cost-sharing arrangement for EMS consultant services as described herein.
2. Payment Obligation
  - a. Tarentum Borough shall contribute its allocated share of the consultant fee, as determined by population, which is \$7,351.73, to be paid within 30 days upon receipt of an invoice.
3. Contract Administration
  - a. The designated representative for the municipalities shall oversee the consultant's engagement, ensuring compliance with the agreed scope of work, and shall coordinate communications among the participating municipalities.
4. Funding Source
  - a. Tarentum Borough shall allocate its contribution from the Reserve Fund.
5. Effective Date
  - a. This resolution shall take effect immediately upon adoption.
