RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA ADOPTING THE 2021 INTERNATIONAL CODE COUNCIL (ICC) CODES.

**WHEREAS**, the Borough of Tarentum, County of Allegheny, Commonwealth of Pennsylvania, is authorized under the Borough Code Section 3301.1 to adopt ordinances and resolutions for any purpose and as deemed beneficial to the borough, 8 Pa C.S. § 3301.1; and

**WHEREAS**, the Council of the Borough of Tarentum recognizes the need to ensure public safety, health, and welfare by adopting up-to-date building codes; and

**WHEREAS**, the 2021 International Code Council (ICC) Codes represent the most current set of comprehensive building safety and fire prevention codes; and

**WHEREAS**, the Council of the Borough of Tarentum desires to adopt the 2021 ICC Codes for application within the Borough.

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Tarentum, County of Allegheny, Commonwealth of Pennsylvania, as follows:

The recitals set forth above are incorporated herein by reference.

**SECTION 1:** The Borough of Tarentum hereby adopts the 2021 International Code Council (ICC) Codes, including, but not limited to, the International Building Code, International Residential Code, International Fire Code, International Plumbing Code, and all other codes as published by the ICC and applicable under state law.

**SECTION 2:** All prior Resolutions conflicting with this Resolution are hereby repealed.
