RESOLUTION OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA ADOPTING THE 2020 NATIONAL ELECTRICAL CODE (NEC).

**WHEREAS**, the Borough of Tarentum, County of Allegheny, Commonwealth of Pennsylvania, is authorized under the Borough Code Section 3301.1 to adopt ordinances and resolutions for any purpose and as deemed beneficial to the borough, 8 Pa C.S. § 3301.1; and

**WHEREAS**, the Council of the Borough of Tarentum recognizes the need to ensure public safety, health, and welfare by adopting up-to-date electrical codes; and

**WHEREAS**, the 2020 National Electrical Code (NEC) represents the most current standard for the safe installation of electrical wiring and equipment; and

**WHEREAS**, the Council of the Borough of Tarentum desires to adopt the 2020 National Electrical Code for application within the Borough.

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Tarentum, County of Allegheny, Commonwealth of Pennsylvania, as follows:

The recitals set forth above are incorporated herein by reference.

**SECTION 1:** The Borough of Tarentum hereby adopts the 2020 National Electrical Code (NEC) for the regulation and enforcement of electrical installations within the Borough.

**SECTION 2:** All prior Resolutions conflicting with this Resolution are hereby repealed.
