**A. Current Projects:**

**1. Tarentum Consent Order and Agreement (Sanitary Sewers)**  
Borough Responsibilities:

**A. 7<sup>th</sup> Avenue- Ormond Street Storm Sewer Project**

- AVNCOG confirmed contract documents completed. Next steps AVNCOG to scheduled preconstruction meeting and then issue notice to proceed.
- Arguing with railroad, who wants to re-review permit application that was approved.

**2. Potable Water Treatment System Improvements**

- GTE is working to submit the permit required before project can start.
- CFA confirmed acceptance of using costars for equipment:
  - Tank (CFA COVID-19 \$1 Million Funded- Use by September 2026)
  - Mechanical (CFA COVID-19 \$300,000 Funded- Use by September 2026)
- Raw Water – Statewide CFA \$300,000
- Appropriations Funds \$200,000
  - Application items: preliminary engineering and environmental items to be completed by GTE
  - Boro selected to use these funds towards Raw Water and Mechanical

- Bid Tab award to be decided on at February meeting.

  - Awarded \$51,000.00 with GEDTF announcements 1/28/2025.
  - GTE is working on specifications and design for the project.
  - Anticipated Spring Construction.
3. GTE discussing Public Works Building, and Fire Department Building with the Borough.
4. GTE discussing Bridge Items with Borough.
