RESOLUTION OF THE BOROUGH OF TARENTUM, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING THE RENUMBERING OF CERTAIN PROPERTIES ON ORMOND STREET AT THE REQUEST OF ALLEGHENY COUNTY 911 FOR PUBLIC SAFETY AND EMERGENCY RESPONSE PURPOSES.

WHEREAS, accurate and logical street addressing is essential to ensure timely and effective emergency response by police, fire, and emergency medical services; and

WHEREAS, Allegheny County 911 has reviewed the existing house numbering on Ormond Street and determined that certain addresses are inconsistent with established county addressing standards; and

WHEREAS, Allegheny County 911 has formally requested that the Borough renumber the properties currently known as **700, 702, and 704 Ormond Street** to **600, 602, and 604 Ormond Street**, respectively, to improve address continuity and emergency response efficiency; and

WHEREAS, the Borough of Tarentum finds that such renumbering serves the best interests of public safety and administrative clarity.

NOW, THEREFORE, BE IT RESOLVED, and it is hereby resolved by the Council of the Borough of Tarentum that the properties currently addressed as **700, 702, and 704 Ormond Street** shall be officially renumbered as **600, 602, and 604 Ormond Street**, respectively.

BE IT FURTHER RESOLVED that the Borough Manager is authorized and directed to notify Allegheny County 911, the Allegheny County Office of Property Assessments, the United States Postal Service, and any other relevant agencies of this address change, and to take any administrative actions necessary to implement this resolution.
