AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF TARENTUM, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 250, ARTICLE III, §250-27.1 OF THE BOROUGH CODE TO REMOVE CERTAIN SPECIAL PARKING REGULATIONS AND ESTABLISH A FIFTEEN-MINUTE PARKING ZONE AT 143 WEST SEVENTH AVENUE.

WHEREAS, Borough Council has reviewed the existing special parking regulations contained within Chapter 250 of the Borough Code; and

WHEREAS, Borough Council has determined that certain parking restrictions are no longer necessary and that a fifteen-minute parking zone is needed at 143 West Seventh Avenue to facilitate customer access and business activity; and

WHEREAS, Borough Council finds that these changes promote the public convenience and efficient use of available parking;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Borough of Tarentum as follows:

SECTION 1. Chapter 250, Article III, §250-27.1, Metered Parking; Other Parking Regulations, is hereby amended as follows:

A. Repealed Provisions

The following subsections are hereby repealed in their entirety:

1. Subsection C – Fifteen-minute parking sign in front of 208 West Seventh Avenue.
2. Subsection D – First three parking spaces on the westbound lane of East Sixth Avenue from Corbet Street reserved for fifteen-minute parking.
3. Subsection E – Reserved parking space for MAC machine customers at 306 East Sixth Avenue.
4. Subsection F – No Parking/Loading zone in Rose Alley behind the Salvation Army building.
5. Subsection H – Fifteen-minute parking zone from the crosswalk at First National Bank on the north side of East Sixth Avenue to Lock Street.
6. Subsection I -Parking shall be limited to 30 minutes on both sides of Fifth Avenue from Lock Street to 209 Fifth Avenue.

B. New Subsection

A new subsection H shall be added to read as follows:

H. Parking shall be limited to fifteen (15) minutes in front of 143 West Seventh Avenue. Appropriate signage shall be installed and maintained by the Borough.

All remaining subsections of §250-27.1 shall remain unchanged and in full force and effect.

SECTION 2: Severability

If any section, provision, or part of this ordinance shall be declared invalid, such decision shall not affect the validity of the remaining provisions of this ordinance.

SECTION 3: Repealer

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4: Effective Date

This ordinance shall take effect immediately upon adoption.
