A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF TARENTUM, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING A ONE-TIME EXTENSION OF THE JUNE 2026 UTILITY BILL PAYMENT DUE DATE

WHEREAS, the Borough of Tarentum recently completed the implementation and conversion of its utility billing system to new BS&A software; and

WHEREAS, the software conversion required the migration and verification of customer account information and utility billing records; and

WHEREAS, Borough Council desires to provide utility customers with additional time to receive, review, and pay their June 2026 utility bills during the transition period; and

WHEREAS, Borough Council finds that a temporary extension of the June 2026 utility bill due date is in the best interests of the Borough and its utility customers.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Tarentum, Allegheny County, Pennsylvania, as follows:

SECTION 1. One-Time Due Date Extension

Notwithstanding any provision of the Borough's utility ordinances, rules, regulations, policies, or billing procedures to the contrary, the payment due date for all utility bills issued during June 2026 shall be extended from June 15, 2026, to June 22, 2026.

SECTION 2. Waiver of Late Penalties

No late fees, penalties, delinquency charges, termination notices, or other collection actions related to the June 2026 billing cycle shall be imposed based solely upon a customer's failure to make payment prior to June 22, 2026.

SECTION 3. Temporary Nature of Extension

This extension is intended solely as a one-time accommodation associated with the Borough's transition to the BS&A utility billing software system. Beginning with the July 2026 billing cycle and all billing cycles thereafter, utility bills shall be due and payable in accordance with the dates and procedures established by the Borough's ordinances, rules, regulations, and policies, including the standard due date of the fifteenth (15th) day of each month.

SECTION 4. Effective Date

This Resolution shall become effective immediately upon adoption.
