A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF TARENTUM, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING THE SUBMISSION OF A MULTIMODAL TRANSPORTATION FUND GRANT APPLICATION TO THE COMMONWEALTH FINANCING AUTHORITY FOR THE WEST 7TH AVENUE REVITALIZATION PROJECT AND DESIGNATING AUTHORIZED OFFICIALS TO EXECUTE REQUIRED DOCUMENTS.

WHEREAS, the Borough of Tarentum is seeking financial assistance through the Commonwealth Financing Authority's Multimodal Transportation Fund Program for the West 7th Avenue Revitalization Project; and

WHEREAS, the West 7th Avenue Revitalization Project will support public safety, pedestrian access, ADA accessibility, traffic signal modernization, multimodal transportation improvements, and continued reinvestment in one of the Borough's important transportation and redevelopment corridors; and

WHEREAS, the total project cost and grant request for the West 7th Avenue Revitalization Project is \$1,964,700.00; and

WHEREAS, the Borough Council of the Borough of Tarentum finds that the project is in the best interest of the Borough and its residents.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Tarentum, Allegheny County, Pennsylvania, as follows:

BE IT RESOLVED, that the Borough of Tarentum of Allegheny County hereby requests a Multimodal Transportation Fund grant of \$1,964,700.00 from the Commonwealth Financing Authority **to be used for the** West 7th Avenue Revitalization Project.

BE IT FURTHER RESOLVED, that the Applicant does hereby designate Dwight Boddorf, Borough Manager, and Scott Dadowski, Council President, as the official(s) to execute all documents and agreements between the Borough of Tarentum and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
