HANDICAP PARKING SPACE APPLICATION

APPLICANTS MUST MEET THE FOLLOWING REQUIREMENTS FOR A RESIDENT-SPECIFIC HANDICAP PARKING SPACE:

1. Applicant must reside at the address for which the parking space is requested and provide current Pennsylvania identification showing that address.
2. Applicant must have a current Pennsylvania Person With Disability Registration Plate **or** Severely Disabled Veteran Registration Plate registered to the applicant. A copy of the current vehicle registration is required.
3. Disclose whether accessible off-street parking is available and whether the residence includes facilities constructed to accommodate the disability.
4. Submit a completed application with the applicable fee and any additional information requested by the Chief of Police.
