A. Current Projects:

1. **Tarentum Consent Order and Agreement (Sanitary Sewers) Borough Responsibilities**
2. **Potable Water Treatment System Improvements**
 - GTE is working to submit the permit required before project can start.
 - CFA confirmed acceptance of using costars for equipment:
 - Tank (CFA COVID-19 \$1 Million Funded- Use by September 2026)
 - Mechanical (CFA COVID-19 \$300,000 Funded- Use by September 2026)
 - Raw Water – Statewide CFA \$300,000
 - Appropriations Funds \$200,000
 - Application items: preliminary engineering and environmental items to be completed by GTE
 - Boro selected to use these funds towards Raw Water and Mechanical
 - Environmental portion of application submitted to USDA.
 - Engineering Items with Borough to be submitted to USDA.
3. **GEDTF 2024 Application- Tripak Blvd Waterline Contract (2.2026 Re-bid)**
 - Awarded \$51,000.00 with GEDTF announcements 1/28/2025.
 - Pay estimate 2 to be reviewed at meeting.
4. **Demolition (913,915, 917 Porter St.) (Contract 4.2026)**
 - Work on-going.
5. **708 Pearl Street Demolition and Roadway Widening (Contract 3.2026)**
 - Work on-going.
6. **CDBG Application- Year 50 (ADA) Handicap Ramp Construction Project (Contract 3.2025)**
 - Awarded \$24,012.00.
 - Award letter sent by Borough to AVNCOG so contract documents can be completed. GTE followed up with AVNCOG on status and they are waited on documents from contractor before the notice to proceed is given.
7. **CFA Small Water and Sewer Grant 2025 (Davidson Street Waterline)-FUNDED \$463,490.00**
 - Contract documents received from CFA, GTE working on design.
8. **910-912 Corbet Street Demolition (6.2026)**
 - GTE working on asbestos information.
9. **Bakerstown Road Hill Street Water Break Project (Contract 5.2026)**
 - Bid tab to be reviewed at meeting.
