A RESOLUTION OF THE BOROUGH OF TARENTUM ACCEPTING THE BID OF SALT CO., LLC FOR THE PURCHASE OF ROAD SALT THROUGH THE SHACOG PURCHASING ALLIANCE

WHEREAS, the Borough of Tarentum participates in the SHACOG Purchasing Alliance for the cooperative purchase of commodities and supplies; and

WHEREAS, the SHACOG Purchasing Alliance solicited bids for the purchase and delivery of road salt for the 2026–2027 winter season, with bids opened on August 10, 2026; and

WHEREAS, Salt Co., LLC submitted a responsive bid for the supply of road salt through the SHACOG Purchasing Alliance; and

WHEREAS, the Borough desires to accept the bid of Salt Co., LLC, including the applicable alternate pricing options offered as part of the bid.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Borough of Tarentum, Allegheny County, Pennsylvania, as follows:

SECTION 1. BID ACCEPTANCE.

The Borough of Tarentum hereby accepts the bid submitted by **Salt Co., LLC** to the SHACOG Purchasing Alliance for the bid opening held on August 10, 2026, for the purchase of road salt for the 2026–2027 winter season.

SECTION 2. ALTERNATE BIDS.

The Borough further accepts the following alternate bid pricing submitted by Salt Co., LLC:

1. **\$160.00 per ton**, FOB mine or storage area, in tri-axle size truck loads of approximately 22 tons; and
2. **\$152.00 per ton**, bulk delivery, for orders placed from **September 1, 2026 through and including October 15, 2026**.

SECTION 3. AUTHORIZATION.

The Borough Manager and other appropriate Borough officials are authorized to place orders and execute any documents necessary to purchase road salt under the accepted bid and alternate pricing options, subject to the Borough's operational needs and available appropriations.

SECTION 4: EFFECTIVE DATE

This Resolution shall become effective immediately upon adoption.
